Breakfast With Diggy OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

CONTEST DESCRIPTION:

The *Breakfast with Diggy Contest* ("Contest") will begin on Wednesday, March 21, 2012 and end on Thursday, March 22, 2012 at 4pm EST ("Contest Period"). The Contest will be conducted exclusively via text message. Ten (10) winners accompanied by one guest each will be awarded breakfast with Diggy Simmons in studio with the Russ Parr Morning Show on Friday, March 23, 2012 at 7:30 AM EST.

HOW TO ENTER:

To participate in the Contest, listeners of WKYS-FM (the "Station") who are legal residents of the U.S., residing within the Washington, DC metropolitan area. must do the following:

- 1. When prompted by on-air announcements during the Contest Period, listeners must text the keyword "DIGGY," their name and the name of their favorite track from Diggy Simmon's new album "Unexpected Arrival" to short code 23088.
- 2. Your mobile device must be capable of sending and receiving text messages to participate in this Contest. Standard text message and/or data rates may apply, and parental consent required for contestants under eighteen (18) years of age.
- 3. Eligible contestants who participate via text message will be entered into the drawing for a chance to win the grand prize.
- 4. One (1) text entry per person. Text entries must be received by 4pm EST on Thursday, March 22, 2012 or they will be void.
- 5. In the event of a dispute regarding the identity of a participant's entry, the entry will be deemed to have been made by the authorized holder of the mobile account at the time the entry was made.

ELIGIBILITY RESTRICTIONS:

- 1. The Contest is open to listeners of WKYS-FM who are legal residents of the U.S. residing within the Washington, DC metropolitan area.
- Employees of the Station, Radio One, Inc., its subsidiaries, affiliates, general sponsors, advertisers, competitors promotional partners, other radio stations in the Washington, DC metropolitan area, and members of the immediate families or those residing in the households (whether related or not) of any of the above are NOT eligible to participate or

- win in this Contest. For purposes of this Contest, family members mean spouses, parents, grandparents, children, and siblings and their respective spouses.
- 3. Once an individual wins a prize in this Contest, they are not eligible to win another prize in this Contest except as specified within these rules.
- 4. Persons who have won a prize in another Contest or promotion of any kind from the Station within the thirty (30) day period immediately preceding the start date of this Contest are not eligible to participate. Only one person per family or household (whether related or not) may win in any promotion from the Station during any thirty (30) day period.

PRIZES:

- 1. Ten (10) winners and one guest will be awarded breakfast with Diggy Simmons in studio with the Russ Parr Morning Show on Friday, March 22, 2012 at 7:30am EST. Station not responsible for winner's transportation or any other expenses required to claim the prize.
- 2. No substitution of prize is offered, no transfer of prize to a third party is permitted and non-cash prizes may not be redeemed for cash value, except as determined by Station management in its sole discretion.
- 3. All Contest winners', parent or legal guardian must sign and date official Station release and waiver forms as requested. If winner is under the age of 18, parent or legal guardian must complete form. Failure to do so will result in winner forfeiting the prize.
- 4. Prize will be awarded only upon winner verification, valid parental consent (for contestants under 18) and final approval by Radio One, Inc. Selected entrant will be notified phone within seven (7) business days after being selected (e.g., date of drawing). The selected entrant will then have seven (7) business days to respond with their information. If the winner or selected entrant is unable to be contacted within seven (7) business days after being selected (e.g. drawing date), is ineligible, fails to claim a prize or fails to return completed and executed release forms and affidavits (if applicable), as required by Station and Radio One, Inc., or if the prize notification or prize is returned undeliverable, that prize will be forfeited and if time permits, at the discretion of the Contest sponsor / and or Contest administrator, an alternate entrant will be selected as the winner by random drawing from among the remaining entries.

It will be at the discretion of the Contest sponsor and / or Contest administrator if another contestant is to be selected as the winner if time permits.

- 3. The grand prize drawing will take place after the conclusion of the Contest Period. Ten (10) prize winners will be selected by random drawing from among all eligible entries received via text message.
- 4. The winner will be contacted by phone provided with instructions for claiming the prize.
- 5. All decisions made by the Station and Radio One, Inc. (together "Company") management regarding any aspect of this Contest are final.

GENERAL CONDITIONS:

- 1. Winners are responsible for all applicable taxes associated with the receipt of the prize. Winner is responsible for transportation to the breakfast location with Diggy Simmons.
